

1st Reading


Mayor Patrick requested Council to waive the second (2nd) reading, Public Hearing and third (3rd) reading. Dale Brussee stated that he thought council should proceed with second (2nd) reading and Public Hearing and then council could decide to waive the 3rd reading and declare it an emergency. This would allow anyone who has any questions to ask them at the Public Hearing. Lynne Snider stated she disagreed with him she does not like the fact that we do not have an officer in the Village. A motion was made by Lynne Snider to waive the second (2nd) reading, Public Hearing, third (3rd) reading on Ordinance 10-4 and declaring an emergency. The motion was seconded by Brian Dunlap. A roll call vote was taken with Lynne Snider, Brian Dunlap and Terry Lynn all voting yes and Dale Brussee voting no. **Motion passed** by a vote of Council-3-1.
