 RESOLUTION NO. 10-11 A RESOLUTION TO APPROVE THE APPLICATION MADE BY HAHN ADVENTURE LLC., NEIL I. BEARD TRUST AND JANET A. BEARD TRUST TO HAVE CERTAIN LAND LOCATED WITHIN THE VILLAGE OF THORNVILLE ON ZION ROAD, MORE SPECIFICALLY DESCRIBED AS PERMANENT PARCEL NOS. 039-000478-0000, 039-000479-0100 AND 039-000479-0000, DESIGNATED AS BEING LOCATED WITHIN AN AGRICULTURAL DISTRICT. 1<sup>st</sup> Reading

**Scott Bender** questioned the fact that Council seems to be passing many issues on an emergency basis and feels there should be more time for the public to be aware and consider. Mayor Patrick explained that many issues have a time frame that must be met such as levies, county auditor requirements, etc.

Brian Dunlap also mentioned that during his 8 month tenure on Council he has not seen any Ordinance/Resolution unnecessarily being passed on an emergency basis.
