Traci added surrounding Villages do have nice gazebos, gardens and sitting areas in their downtown areas and it had been an idea in the past. We would need to see if the property owner would be interested in selling the Village the lot for this purpose. Committee member Kim Billman added that the Village of Bremen has this and they sometimes offer live music also. Traci will contact the property owner and see if he is interested in selling the lot.
