Jeff Carr- EDG Environmental Services: Jeff explained that Village Administrator Traci Sturgill invited him to attend tonight's meeting to discuss the new grant that just became available for water & wastewater infrastructure projects called the WWIG grant. He, along with Traci & Heidi sat through the online presentation detailing the grant details. This grant opens tomorrow, November 28th and the submittal deadline is approximately 30 days. There is approximately \$750 million dollars available. This is a first come, first serve state level grant from ODOD. We looked at submitting for our wastewater treatment plant upgrade but with the time restraints attached to the grant of spending, we are unable to meet those with that project. We then looked at our I & I portion of the treatment plant project. The grant will not fund design costs only construction therefore any projects must be "shovel ready" when submitted. Traci advised \$1.3 million of the wastewater treatment plant quote was for I & I and we really need this part of the project completed whether we end up moving forward with the PC Commissioners and a new plant or not. The Village's I & I is very high and a real problem. We are paying to treat water we don't need too on a regular basis. The council would need to decide tonight if they would like to move forward applying for the grant that has to be submitted tomorrow morning. The Village will also be required to provide funds of \$44,250 to cover the survey and engineering plans to submit the application which is available in the sewer fund. The I & I project will also provide the Village with mapping of all our manholes which we currently don't have available.

Mayor Kaetzel asked for a **motion** to move forward with authorizing RCAP to submit the I & I project application to Ohio Dept of Development. **Motion** made by Council President Sterling Krout and was seconded by Council member Erica O'Neill. A roll call vote was taken with all council members voting aye.

Police Report for November 2023: Chief Williams reviewed the police activity for November. He advised it was a relatively quiet month. Officer Josh Moore was away on military training for a couple weeks. He also updated the council on an old case from 2021 that we stopped a motorcycle for running a red light, a chase pursued and when we caught him, he was in possession of a large amount of cocaine, meth, fentanyl and over \$19,000 in cash. He has since pleaded guilty to all charges. The court has now awarded us the cash which has been sitting safely locked up in the

safe since the arrest. Chief Williams will create a line item in the police department fund to deposit the funds, which can only be used for special purposes.

It can't be used to replace levy funds. It can be used for a cruiser, radios, and miscellaneous purchases like those. Chief Williams also added he is currently taking his required CPT training. Mayor Kaetzel asked for an update on the school zone monitoring software. Chief Williams advised after sending it for review with Attorney Zets, he highly advised against us taking part in this. He has represented several companies like this in lawsuits. We also cannot run the tickets through Mayor's court like we were advised we could. They would all have to go through municipal court, which he was mislead on from the company when presented. Mayor Kaetzel asked if there were any funds in the police budget to purchase a speed sign. Chief Williams stated there should be enough in the carryover for next year. Village Administrator Traci Sturgill added that the council had previously voted against purchasing one of these and Chief Williams added yes, when he first started here. Mayor Kaetzel thought that was due to money restraints and no police levy. We can revisit purchasing one in 2024 with the council again. Council member Ashley Moore asked if one could be donated? Traci advised yes, that would be great.

Council member Kim Billman arrived at 7:20 pm.

They also said they would be willing to go into contract on a yearly basis for something like this, but all of this will need to go to committees in 2024. She just wanted everyone to know that it was looked into, and Village Administrator Traci

Sturgill has called around and received quotes on new leaf vac machines. The one they use in Millersport did cost \$80,000. Traci advised she has quotes ready to bring to committees in January. She did find one that will work for our village that you pull behind the truck, it has the box attached and the cost is around \$26,000.

She has been trying to get them to understand that everything they are doing is wonderful, but they do need to get permission from the Village Council and Mayor prior to moving forward with plans. Nobody here had any idea they were going to decorate all the baskets around town this year. While they do look great, we have a couple of local ladies in the Village who have purchased items for the baskets and decorate them every year on their own time and money. She is worried they will be upset now but nobody knew this was taking place until pictures were posted on Facebook on a Saturday morning. She did advise the TAC Committee of this, and they said they would contact them to let them know the Village was unaware they were decorating the baskets.

Judge Cooperrider continues to send out emails to multiple people trying to set up meetings to apply for grant funds without first getting the approval of the Village Council & Mayor.

While we know she is trying to do great things for the Village, the Village must decide if and what grants we are applying for. Grants require match funds, attorney fees and miscellaneous fees out of the funds of the Village. Council member Ashley Moore advised Judge Cooperrider had also asked her to discuss the Village purchasing the bank tonight during council comments. She wants us to purchase the bank, remodel it and then lease it. Judge Cooperrider thinks the Village has the funds to do all this. Traci just wanted Council to be made aware of what all has been going on with this situation. She is aware of all the grants when they come out and brings to council & Mayor Kaeztel those grant opportunities, she feels the Village can go after and afford.
