RCAP Rate Study Presentation: Nathan Davis and Asberry Brown from RCAP presented the results from the water and sewer rate study they had completed over the past 3-4 months. They reviewed our last 5 years expenses and revenues along with the future expenses they foresee in the future including plant maintenance, upgrades, and replacements. The Village of Thornville current rates are not producing the revenue they need to keep up with the expenses and economic increases that are coming and have taken place in the past couple years. Our current water & sewer rates are way below the percentage required to qualify for government loans and grants and what the EPA looks at. Our current rates are extremely low for the median household income we have of \$87,000. The conclusion of the rate study recommends the Village increase utility rates a total of \$35 monthly over the next 5 years between water & sewer side. The rate study completed is based on the Village customers only, allowing us to be sustainable if the county were ever to go elsewhere. They also recommend we set up an emergency fund yearly for both water and sewer and keep putting money towards it to save up for unknown emergencies, grant fund matching and future plant replacement. Manhole inspections were also recommended as part of our yearly maintenance along with curb stop replacements on the water side.

Council member Ashley Moore arrived at the meeting at 7:20 p.m.

**Refuse/ Trash Contract:** Village Administrator Traci Sturgill advised council we have 4 bids submitted for the new trash contract renewal. WinWaste Innovations came in at the lowest monthly cost and they have provided excellent service to the Village for the past 2-year contract. We have had no issues or complaints with them. Everyone has a spreadsheet showing all 4 of the bids for review.
