#### **New Business:**

i. IAM GIS Demonstration: Administrator Brofford explained that this is the program suggested to her by EDG, who offered a more live tutorial than the one provided. Administrator Brofford explained she was a fan of EDG being familiar with the program and able to help as needed. Committee Chair Dale Brussee questioned how information would be input to the system, to which Administrator Brofford explained the Excel Sheet based system. Administrator Brofford explained that there is a \$1,000 set up fee, and a three-year contract costs \$3,000. With the Committee in agreement, Administrator Brofford is bringing the proposal to Council.

## ii. Hydrant Repair & Water Valves:

Administrator Brofford informed the Committee that 2 repairs were still needed following the repairs that had already been completed, and these repairs are not able to be isolated, so water will need to be shut down to all customers. Committee Chair Dale Brussee questioned when these would take place. Administrator Brofford explained to the Committee that the Village was looking for their guidance following the public reactions to the last repairs, but were leaning towards night time shut downs & repairs. Committee Chair Dale Brussee suggested notifying customers beforehand, and doing the repairs between 11P and 5A despite an overnight work upcharge, to which the committee agreed.
