PUBLIC HEARING ON APPLICATION FOR PLACEMENT OF FARMLAND IN AN AGRICULTURE DISTRICT

Mayor Beth Patrick **opened** the public hearing at 7:01 PM and Neil Beard presented the reasons that he would like Council to change the newly purchased property from agriculture to farmland. After discussion Council advised that they have no objection to the proposed cleanup of the property that Mr. Beard proposed but he will need to speak to the township Fire Chief concerning the burning of brush, etc. which seemed to be his main issue at this time. Ron Koehler is also concerned about a water line crossing the property and the future issues it could cause. After much discussion Council said they will take all under advisement and will let Mr. Beard know the outcome within 30 days.

9-11 Proclamation

The American Legion in accordance with the United States Congress requested that the Village of Thornville proclaim September 11, 2010 as Patriot Day. Mayor Patrick read the proclamation declaring it so and encouraged all residents to fly their American Flag on the day set forth.

Risk Insurance

Terry Lynn made a **motion** to accept Wichert Insurance for the coming 2011 year seconded by Lynne Snider. **Motion passed** by a voice vote of Council 5-0.

Health Insurance

Once again Village Administrator Ron Koehler recommended that Council stay with the current health insurance company, Medical Mutual of Ohio, as they also, after examination provides the best coverage and cost to the Village.


