Call to Order/Pledge of Allegiance:

The Village of Thornville Special Council meeting was called to order by Mayor Gavin Renner on September 21, 2015 at 7:30 p.m. by saying the Pledge of Allegiance.

Roll Call:

Roll call was taken with all members present.

Olivia Newbold – Council Candidate

Mayor Gavin Renner made a request that Council approve Miss Olivia Newbold to the open Council seat. With no discussion held, a **motion** was made by Councilwoman Lynne Snider to approve Miss Olivia Newbold to the open Council seat and was seconded by Councilwoman Mary Renner. A roll call vote was taken with all members voting yea. **Motion passed 5-0.**

Miss Olivia Newbold took the Oath of Office, and was seated at the Council table.

2015 Amended Committee Assignments

Mayor Gavin Renner asked Councilman Ryan Yzenski and Councilwoman Olivia Newbold their preferences for committee assignments. Discussion was held regarding how the Council Zoning Representative is appointed by Council for the term of the Zoning Representative. The current Council Zoning Representative's term does not expire until December 31, 2017. Discussion was held regarding committees, and Mayor Gavin Renner gave a brief description of each committee. Councilman Ryan Yzenski was assigned to Public Facilities and the Personnel Committees. Councilwoman Olivia Newbold was assigned to Parks and Recreations, Finance and Council Rules Committees.
