New Business:

a. Replacing/Upgrading Water Meters

Council Member Aaron Hoppel asked about the possibility of replacing/upgrading water meters in the Village. Several ideas were discussed and it was noted that Somerset is getting a new system and the Company (Neptune) would give a discount if the village decided to join them. Fiscal Officer stated she would get the information from Somerset. It was decided that some research needed to be done and the Village Administrator stated that he would look into it when the I&I project was completed.

b. Direct Deposit for Employees

Mayor Lackey stated that this had been asked about by employees and questioned the Fiscal officer about the process. The Fiscal officer explained the process for submitting time sheets as well as how the first direct deposit would affect employees. Mayor Lackey stated that she would like to move forward and asked the Fiscal officer to check with the bank.

Comments and Announcements:

Mayor Lackey announced that it had been confirmed that the Village was not allowed to build on the site of the pool as it is designated to be a park. She stated that it will have to be demolished but that she would like to see if there are any grant opportunities whether it be for another pool or a rec center. Council member Tasia Savage voiced that she would like to see a building that could be used/rented out year-round.

The Parks and Rec Levy was discussed as part of that covers general maintenance for the village and parks. Council President Dale Brussee stated that he will not be mowing grass this year so the Village will have to find and pay someone.

The Village entrance signs were discussed. Council Member Tasia Savage explained the costs for the village as well as the cost for each business that would like their own smaller sign.

Village Administrator brought up cold storage for Village equipment. There are several pool related items in the buildings at the park. Council president Dale Brussee stated that he had spoken with one of the trustees in Somerset and discussed Somerset Pool's potential interest. Fiscal Officer stated that she would mention it to their parks and rec board and Chris Shonk.

Sam Brown mentioned empty chlorine containers and calling to have them picked up because they cannot be thrown in the trash. He also discussed potential small repairs that may be needed at the maintenance building near the park.
