RESOLUTION #25-13: A RESOLUTION DECLARING THE NECESSITY TO LEVY A RENEWAL TAX IN EXCESS OF THE (10) MILL LIMITATION IN THE AMOUNT OF ONE (1.0) MILL FOR CURRENT EXPENSES AND REQUESTING THE QUESTION OF SUCH TAX LEVY TO BE SUBMITTED TO THE ELECTORS OF THE VILLAGE OF THORNVILLE AND DECLARING AN EMERGENCY:

Mayor Lackey asked for a motion to amend Resolution #25-13 to correct the estimated tax revenue and dollar amount per \$100 thousand in county auditor appraised value due to an error in the County Auditor Certificate, amend County Auditor estimates will collect \$242,400.00 annually to \$21,500.00 annually, and amend at a rate not exceeding 1.00 mill for each \$1 of taxable value, which amounts to \$31.00 for each \$100,000.00 of the County Auditor's appraised value for five years to \$18.00 for each \$100,000.00 of the County Auditor's appraised value for five years. #### g. Donation to Thornville Police Department:

Council Member Tony Taylor explained that his company, Veterans Claims Paid's philanthropy donates to organizations support veterans, first responders, and their families. Council Member Tony Taylor presented Chief Palmer with a \$2,500 check intended to fund any needs the Police Department may have. Mayor Lackey asked for a motion to accept the donation. Council Member Lynne Snider made the motion, and was seconded by Council Member Eric Wilkins. A roll call vote was taken, with five members voting aye and one member abstaining.

#### **Comments & Announcements:**

- **a.** Mayor Lackey suggested aligning the Food Truck Festival, currently scheduled for 3PM-7PM, with the Perry County Chamber of Commerce Car Show, currently scheduled for 1PM-7PM. Discussion was held regarding best options regarding time to align the events. The decision was made to check with each scheduled Food Truck on availability before promotion a change in time.
- **b.** Council Member Aaron Hoppel questioned the progress of the Foster Manor Park sale. Administrator Brofford explained that the survey had been sent to the County Engineers for review but did not expect a response until after the Perry County Fair had concluded. Administrator Brofford explained that the property would be sold on GovDeals and require legislation from Solicitor Zets.
- c. Lisa Sharpe, a resident of Thornhill Estates, questioned the Village's paving schedule, stating that prior administrations had indicated paving in her neighborhood would occur in 2025, but she was recently told it would be delayed until 2027. She expressed concern that other areas of the Village had been paved sooner despite what she described as the poor condition of Thornhill Estates roads. Ms. Sharpe also raised questions about the Village budget, referencing recent water system issues, the lack of a Village pool or splash pad, and inquired whether the Village was complying with road maintenance requirements under the Ohio Revised Code.

  Council Member Aaron Hoppel responded that multiple areas of the Village are in need of repairs and all residents contribute through taxes. Council Member Tony Taylor clarified that infrastructure projects such as paving, water, and recreation are funded from separate accounts, and that Thornville faces financial challenges common to small
- d. Ms. Sharpe suggested the Village improve communication with residents and stated that many are frustrated with administration. Council Member Lynne Snider noted that meetings are regularly posted and open to the public, but attendance remains low, including at a recent levy informational meeting.
  Administrator Melissa Brofford informed Ms. Sharpe that Ordinance 25-13 is the Village's 2026 Budget and includes financial data for 2025, the two preceding years, and projections for 2026. She noted that the budget is available on the Village website. Administrator Brofford further explained that the Village spent approximately \$50,000 more than it received in water revenue last year due to necessary leak repairs and the replacement of fire hydrants that had gone unrepaired under the previous administration for the past five years. She added that two hydrants are still in need of repair.

villages, which underscores the importance of levy support.

- e. Landon Hinkle, a Village resident, submitted photographs to Council showing vehicles parked on South Church Street, which he stated demonstrate that parked vehicles do not impede traffic or emergency access. He referenced a petition he circulated opposing Ordinance 25-17, which he claimed included over 100 signatures. Mr. Hinkle cited comparable parking conditions in other areas of the Village that allow on street parking with no edge lines. Mackinley Hinkle, another resident, stated that removing the "No Parking" signs on
  - South Church Street would make Church Street residents happy.
  - Tim Moore, a resident of South Church Street, expressed that unsafe parking has not been a significant issue and suggested enforcement of existing laws would be sufficient.
- f. General Maintenance Worker Sam Brown explained that hole patching had begun in Thornhill Estates, but was on hold while the dump truck is in the shop. General Maintenance Worker Sam Brown explained that more cold mix had been bought, but multiple roads with problems exist in the Village, and potholes in Thornhill had been addressed in the past year.
- g. Council Member Tony Taylor suggested looking into upcoming grant releases from the Community Foundation for Perry County. Ms. Sharpe offered her help in the application process if an opportunity arose.
