**Call to Order:**

Mayor Lackey called to the meeting to order on January 13<sup>th</sup>, 2025 at 6:08PM by reciting the Pledge of Allegiance.

**Resignation of Sterling Krout:**

Mayor Lackey informed Council that Council Member Sterling Krout's relocation had been set in place, and his resignation officially turned in. Mayor Lackey expressed Mr. Krout's sincerest well wishes to each member of Council individually and as a whole, as well as to Administrator Brofford. Mayor Lackey asked for a motion to accept Mr. Krout's resignation. Council Member Lynne Snider made the motion, and was seconded by Council Member Tony Taylor. A roll call vote was taken, with all members voting aye.

**Review & Approval of Special Organizational Agenda for January 13<sup>th</sup>, 2025:**

**Election of Council President Pro Temp:**

Mayor Lackey explained that a new Council President is elected at the beginning of every calendar year, and asked if there were any nominees. Council Member Tasia Savage asked what was expected or required of the Council President. Administrator Brofford explained that the Council President must become bonded to sign checks as needed, and that Council President steps in if the Mayor is unavailable in any way. Council Member Dale Brussee nominated himself for the position, and Council Member Lynne Snider nominated Council Member Tasia

Savage for the position. Council Member Tasia Savage accepted the nomination. Council Member Tony Taylor asked both nominees about the position. Council Member Dale Brussee explain he was Mayor in 2004 and has been a Council Member since the 1990s. Council Member Dale Brussee explained he was more available now that he's retired than he was when acting Mayor, and felt he could fill any role the Mayor could be unavailable for. Council Member Tasia Savage explained that she was curious about taking on a bigger role in council and had been on Council for 2 years.

All Council Members turned in paper ballots to the Council Clerk, who announced 2 votes for Council Member Dale Brussee and 2 votes for Council Member Tasia Savage. Mayor Lackey, as the tiebreaking vote, cast her vote for Council Member Dale Brussee, due to his availability in the Village.

**2025 Committee Assignments:**

**2025 Meeting Schedule:**

Mayor Lackey reminded Council that Council will begin meeting regularly the second and fourth Monday every month, with committees added on at the beginning of the month as needed. Mayor Lackey explained that this is to pass Ordinances and Resolutions without emergency wording and motions moving forward. Council Member Tony Taylor asked if there would be modifications to this schedule, to which Mayor Lackey answered no, but committees won't meet every month, just as needed. Administrator Brofford explained Zoning may not meet as often as scheduled, and Council President Dale Brussee reminded Council that Zoning is a standing committee and notice must be put out if a meeting isn't being held. Council Member Tony Taylor made a motion to accept the 2025 Schedule with 2 meetings per month, and that notice about the cancelled Zoning Meeting be put out, and was seconded by Council Member Tasia Savage. - i. **ORDINANCE 25-01 ESTABLISHING A NEW COMPENSATION AND PAY SCHEDULE FOR THE VILLAGE OF THORNVILLE, REPEALING ALL PRIOR**

**SALARY ORDINANCES AND DECLARING AN EMERGENCY:**

Council President Dale Brussee pointed out that compensation values in word and numeric form did not match. Administrator Brofford said that is something she can fix without issue. Council President Dale Brussee made a motion that Sections 2, 3, 7, and 8 of Ordinance 25-01 be corrected to have matching values. Council Member Tony Taylor seconded the motion. 
