

ORDINANCE 26-10  
ADOPTED 7-6-2026

AN ORDINANCE AMENDING AND REVISING SPECIFIC LINE-ITEMS IN THE APPROPRIATIONS OF EXPENDITURES FOR THE VILLAGE OF THORNVILLE FOR THE 2026 CALENDAR YEAR AND DECLARING AN EMERGENCY

WHEREAS, the Village of Thornville, Ohio, is authorized to adopt the Municipal Budget for the fiscal year beginning January 1, 2026, and ending December 31, 2026; and

WHEREAS, with Ordinance 25-29, adopted on November 11, 2025, Council for the Village of Thornville established the Village’s annual appropriations for the fiscal year ending December 31, 2026; and

WHEREAS, the Fiscal Officer has recommended amending the appropriations to supplement those appropriations previously adopted by Council.

NOW, **THEREFORE, BE IT ORDAINED** by the Council of the Village of Thornville, County of Perry, State of Ohio:

SECTION 1: The Village of Thornville 2026 Appropriations shall be amended as follows:

SECTION 2: It is hereby found and determined that all formal action of this Council concerning and relating to the passage of this Ordinance were adopted in open meeting of this Council,

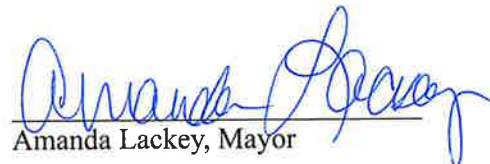

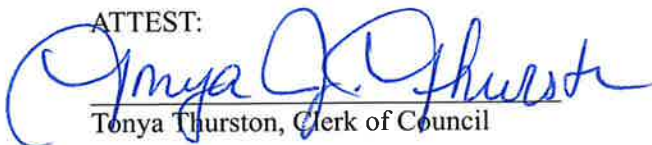

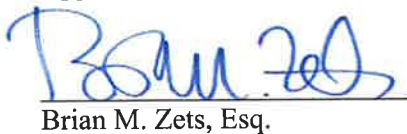
