

ORDINANCE NO. 09-03

AN ORDINANCE TO AMEND ORDINANCE NUMBERS 06-09, 08-07 & 08-17, THE ORDINANCES TO FIX THE SALARIES OF CERTAIN POSITIONS OF THE VILLAGE OF THORNVILLE.

WHEREAS, Ohio Revised Code Section 731.13 authorizes the legislative authority of a Village to fix the compensation of all officers, clerks, and employees of the Village; and,

WHEREAS, Council hereby desires to amend Ordinance Numbers 06-09, 08-07 & 08-17 which previously established the salaries of certain positions of the Village of Thornville.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF THORNVILLE, OHIO, THAT:

- Section 1. The salaries and rates of compensation for certain officers and employees of the Village of Thornville, Ohio, are hereby amended as follows:
- Section 2. Hourly pay for the Account Clerk shall be Eleven Dollars and Ninety-Six Cents (\$11.96) per hour paid bi-weekly.
- Section 3. The salary of the Fiscal Officer shall be Fifteen Thousand Three Hundred Dollars (\$15,300) paid monthly.
- Section 4. Hourly pay for clerical help for the Village shall be Seven Dollars and Thirty Cents (\$7.30) per hour paid bi-weekly.
- Section 5. The salary of the Village Administrator shall be Twenty Three Thousand Dollars (\$23,000) paid monthly.
- Section 6. The hourly pay for the full-time Licensed Water/Sewer Operator shall be Twenty Dollars and Forty Cents (\$20.40) per hour paid bi-weekly.
- Section 7. The hourly pay for the full-time Utility Labor for the Water/Sewer shall be Eleven Dollars and Thirty-One Cents (\$11.31) per hour paid bi-weekly.
- Section 8. The hourly pay for the part-time hourly labor for the Water/Sewer Department shall be Ten Dollars and Twenty Cents (\$10.20) per hour paid bi-weekly.
- Section 9. The salary of the part-time Chief of Police shall be Nine Thousand, Nine hundred, Seventy-Three Dollars and Fifty-Six (\$9,973.56) paid monthly.
- Section 10. The hourly pay for the full-time Police Officer shall be Ten Dollars and Twenty Cents (\$10.20) per hour paid bi-weekly.
- Section 11. The hourly pay for the part-time Police Officer shall be Eight Dollars and Eighty-Nine Cents (\$8.89) per hour paid monthly.
- Section 12. The hourly pay for the full-time General Maintenance Labor shall be Twelve Dollars and Forty-Two Cents (\$12.42) per hour paid bi-weekly.
- Section 13. The salary for the Zoning Inspector shall be One Hundred Dollars (\$100) and Thirty Percent (30%) of monies received by the Village for permits paid quarterly.
- Section 14. The hourly pay for the part-time Zoning Secretary shall be Seven Dollars and Thirty Cents (\$7.30) per hour paid quarterly.
- Section 15. The hourly pay for the part-time Clerk of Council shall be Nine Dollars and Seventy Seven Cents (\$9.77) per hour paid monthly with hours not to exceed 1.56

- Section 7. The hourly pay for the full-time Utility Labor for the Water/Sewer shall be Eleven Dollars and Thirty-One Cents (\$11.31) per hour paid bi-weekly.
- Section 8. The hourly pay for the part-time hourly labor for the Water/Sewer Department shall be Ten Dollars and Twenty Cents (\$10.20) per hour paid bi-weekly.
- Section 9. The salary of the part-time Chief of Police shall be Nine Thousand, Nine hundred, Seventy-Three Dollars and Fifty-Six (\$9,973.56) paid monthly.
- Section 10. The hourly pay for the full-time Police Officer shall be Ten Dollars and Twenty Cents (\$10.20) per hour paid bi-weekly.
- Section 11. The hourly pay for the part-time Police Officer shall be Eight Dollars and Eighty-Nine Cents (\$8.89) per hour paid monthly.
- Section 12. The hourly pay for the full-time General Maintenance Labor shall be Twelve Dollars and Forty-Two Cents (\$12.42) per hour paid bi-weekly.
- Section 13. The salary for the Zoning Inspector shall be One Hundred Dollars (\$100) and Thirty Percent (30%) of monies received by the Village for permits paid quarterly.
- Section 14. The hourly pay for the part-time Zoning Secretary shall be Seven Dollars and Thirty Cents (\$7.30) per hour paid quarterly.
- Section 15. The hourly pay for the part-time Clerk of Council shall be Nine Dollars and Seventy-Seven Cents (\$9.77) per hour paid monthly with hours not to exceed 56 hours per month.
- Section 16. The hourly pay for the part-time Mayor's Court Clerk shall be Nine Dollars and Seventy-Seven Cents (\$9.77) per hour paid monthly with monthly hours not to exceed 40 hours per month.

Section 17. The hourly pay for the Records Retention Secretary shall be Seven Dollars and Thirty Cents (\$7.30) per hour paid monthly (up to \$2000.00 per year).

Section 18. The salary of the full-time Chief of Police shall be Twenty Seven Thousand, Five hundred, Eighty Dollars and Eighty Cents (\$27,580.80) paid bi-weekly.

Section 19. The salary pay for the Pool Manager shall be \$5250.00 per season paid bi-weekly.

Section 20. The hourly pay for the Assistant Pool Manager shall be Seven Dollars and Fifty-Five Cents (\$7.55) per hour paid bi-weekly.

Section 21. The hourly pay for the pool concession stand and lifeguards shall be Seven Dollars and Fifty-Five Cents (\$7.55) per hour paid bi-weekly.

~~Section 22. The Auxiliary Police Officer shall no longer receive compensation.~~ *Da*

Section 23. This Ordinance shall take effect and be in force at the earliest time allowed by law.
