

AN ORDINANCE TO AMEND ORDINANCE NUMBERS 10-16, 11-05, 11-06, 11-11 THE ORDINANCES TO FIX THE SALARIES OF CERTAIN POSITIONS OF THE VILLAGE OF THORNVILLE.

WHEREAS, Ohio Revised Code Section 731.13 authorizes the legislative authority of a Village to fix the compensation of all officers, clerks, and employees of the Village; and,

WHEREAS, Council hereby desires to amend Ordinance Numbers 10-16, 11-05, 11-06, 11-11 which previously established the salaries of certain positions of the Village of Thornville.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF THORNVILLE, OHIO, THAT:

- Section 1. The salaries and rates of compensation for certain officers and employees of the Village of Thornville, Ohio, are hereby amended as follows:
- Section 2. Hourly pay for the Administrative Assistant shall be Fourteen Dollars and Thirty-Two Cents (\$14.32) per hour paid bi-weekly.
- Section 3. The salary of the Fiscal Officer shall be Nineteen Thousand Dollars (\$19,000) paid monthly.
- Section 4. Hourly pay for clerical help for the Village shall be Seven Dollars and Seventy Cents (\$7.70) per hour paid bi-weekly.
- Section 5. The salary of the Village Administrator shall be Twenty Three Thousand Six Hundred Ninety Dollars (\$23,690) paid monthly.
- Section 6. The hourly pay for the full-time Licensed Water/Sewer Superintendent shall be Twenty Five Dollars (\$25.00) per hour paid bi-weekly.
- Section 7. The hourly pay for the full-time Licensed Water/Sewer Operator shall be Twenty Dollars and Fifty Cents (\$20.50) per hour paid bi-weekly.
- Section 8. The hourly pay for the full-time Utility Labor for the Water/Sewer shall be Eleven Dollars and Sixty-Five Cents (\$11.65) per hour paid bi-weekly.
- Section 9. The hourly pay for the part-time hourly labor for the Water/Sewer Department shall be Ten Dollars and Fifty-One Cents (\$10.51) per hour paid bi-weekly.
- Section 10. The salary of the part-time Chief of Police shall be Ten Thousand, Two hundred, Seventy-Two Dollars and Seventy-Seven Cents (\$10,272.77) paid monthly.
- Section 11. The hourly pay for the full-time Police Officer shall be Ten Dollars and Fifty-One Cents (\$10.51) per hour paid bi-weekly.
- Section 12. The hourly pay for the part-time Police Officer shall be Nine Dollars and Sixteen Cents (\$9.16) per hour paid monthly.
- Section 13. The hourly pay for the full-time General Maintenance Labor shall be Fourteen Dollars and Thirty Cents (\$14.30) per hour paid bi-weekly.
- Section 14. The salary for the Zoning Inspector shall be Two Hundred Dollars (\$200) and Thirty Percent (30%) of monies received by the Village for permits paid monthly.
- Section 15. The hourly pay for the part-time Zoning Secretary shall be Nine Dollars and Fifty Cents (\$9.50) per hour paid monthly.
- Section 16. The hourly pay for the part-time Clerk of Council shall be Twelve Dollars (\$12.00) per hour paid monthly with hours not to exceed 56 hours per month.
- Section 17. The salary for the part-time Mayor's Court Clerk shall be Two Hundred Dollars (\$200) paid monthly with monthly hours not to exceed 27 hours per month.

Section 18. The salary of the full-time Chief of Police shall be Thirty Four Thousand Dollars (\$34,000) paid bi-weekly.

Section 19. A stipend for Auxiliary Police Officers, upon fulfillment of required hours and completion of a full year of service with the Village of Thornville, shall be Two Hundred Dollars (\$200) per year.

Section 20. This Ordinance shall take effect and be in force on January 5, 2012
