

ORDINANCE: 12-08

AN ORDINANCE AUTHORIZING THE VILLAGE ADMINISTRATOR, OR HIS DESIGNEE, TO ADVERTISE BIDS FOR REFURBISHMENT AND MAINTENANCE OF THE WATER TOWER AND DECLARING AN EMERGENCY

WHEREAS, Council for the Village of Thornville understands that in order to help ensure the longevity and continued use of the Village's water tower, the tower must be properly maintained; and

WHEREAS, having done some initial research into refurbishment and maintenance costs for the water tower, Council for the Village of Thornville anticipates the cost will be greater than \$25,000.00; and

WHEREAS, Council for the Village of Thornville now wants to advertise bids and proceed with refurbishment and maintenance of the Village of Thornville's water tower.

NOW, **THEREFORE, BE IT ORDAINED** by the Council of the Village of Thornville, County of Perry, State of Ohio:


SECTION 1: Council for the Village of Thornville hereby authorizes and directs the Village Administrator, or his designee, to advertise bids for refurbishment and maintenance of the Village water tower, for not less than two nor more than four consecutive weeks in a newspaper of general circulation within the Village or as provided in R.C. 7.16. The bids shall be opened and publicly read by the Village Administrator, or his designee, at the time, date, and place as specified in the advertisement to bidders or specifications,

SECTION 2: It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that any and all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements of the laws of the State of Ohio.


SECTION 3: All prior legislation, or any parts thereof, which is/are inconsistent with this Ordinance is/are hereby repealed as to the inconsistent parts thereof.

SECTION 4: Council declares this to be an emergency measure immediately necessary for the preservation of the public peace, health, and safety of this municipality and the further reason that the Village needs to bid this project, award a contract, and begin the maintenance as soon as possible. Wherefore, provided this Ordinance receives the required affirmative votes of Council, it shall take effect and be in full force immediately upon passage by Council.
