AN ORDINANCE FINDING PERSONAL PROPERTY IS NOT NEEDED FOR MUNICIPAL PURPOSE AND AUTHORIZING/DIRECTING THE VILLAGE ADMINISTRATOR, OR HER DESIGNEE, TO ADVERTISE BIDS TO SELL THE PROPERTY AND DECLARING AND EMERGENCY

WHEREAS, the Village of Thornville currently owns a 1991 C1500 Chevy Pickup, 1999 Ford Crown Victoria, and a 1995 Chevy 3500 Dump Truck; and

WHEREAS, the Board, Officer, or Director having supervision or management of these vehicles approves of selling this personal property because they are no longer need for municipal purposes; and

WHEREAS, R.C. 721.15 requires personal property not need for municipal purposes, with an estimated value of more than one thousand dollars, be authorized by ordinance and made in writing by the highest and best bid. As such, advertisement of bids is necessary.

NOW, **THEREFORE**, **BE IT ORDAINED**, by the Council of the Village of Thornville, County of Perry, State of Ohio that:

SECTION 1: Council for the Village of Thornville has determined the following vehicles each have an estimated value of more than one thousand dollars and are no longer needed for municipal purposes:

1991 C1500 Chevy Pickup VIN Number: 1GCEC14H7ME176829 Mileage: 209,594

1999 Ford Crown Victoria VIN Number: 2FAFP71W2XX186028 Mileage: 98,848

1995 Chevy 3500 Dump Truck VIN Number: 1GBJK34F8SE245024 Mileage 24,557.6

- SECTION 2: The Village Administrator, or her designee, is hereby instructed and authorized to advertise, not less than two (2) nor more than four (4) consecutive weeks in a newspaper of general circulation within the municipal corporation, or as provided in R.C. 7.16, the sale of the personal property/police cruiser, listed and identified in Section 1, to the highest and best bidder.
- SECTION 3: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision making bodies of the Village of Alexandria which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.
- SECTION 4: All prior legislation, or any parts thereof, which is/are inconsistent with this Ordinance is/are hereby repealed as to the inconsistent parts thereof.
- SECTION 5: This Ordinance is declared to be an emergency measure necessary for the health, safety and welfare of the citizens of Alexandria and the further reason that Council needs to immediately begin the bid process and sell these unneeded vehicles. Wherefore, provided this Ordinance receives the required affirmative votes of Council, this Ordinance shall take effect and be in force immediately upon passage by Council
