ORDINANCE No.: 13-18

AN ORDINANCE TO REVISE THE CODIFIED ORDINANCES BY ADOPTING CURRENT REPLACEMENT PAGES AND DECLARING AN EMERGENCY.

WHEREAS, various ordinances of a general and permanent nature have been passed by the Council of the Village of Thornville which should be included in the Codified Ordinances; and

WHEREAS, certain provisions within the Codified Ordinances should be amended to conform with current State laws as required by the Ohio Constitution and;

WHEREAS, the Village of Thornville has heretofore entered into a contract with the Walter H. Drane Company to prepare and publish an annual supplement to the Codified Ordinances which is before Council;

NOW, **THEREFORE**, **BE IT ORDAINED** by the Council of the Village of Thornville, County of Perry, State of Ohio:

SECTION 1: The ordinances of the Village of Thornville, Ohio, of a general and permanent nature, as revised, re-codified, rearranged and consolidated into component codes, titles, chapters and sections within the 2013 Replacement Pages to the Codified Ordinances are hereby approved and adopted.

SECTION 3: The complete text of the sections listed above is set forth in full in the current replacement pages to the Codified Ordinances which are hereby attached to hereto as Exhibit A and incorporated herein by reference. Notice of adoption of each new section by reference to its title shall constitute sufficient publication of new matter contained therein.

SECTION 4: All prior legislation, or any parts thereof, which is/are inconsistent with legislation is/are hereby repealed as to the inconsistent parts thereof.

SECTION 5: It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that any and all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements of the laws of the State of Ohio.

SECTION 6: Council declares this to be an emergency measure immediately necessary for the preservation of the public peace, health, and safety of this municipality and the further reason that there exists and imperative necessity for the earliest publication and distribution of current replacement pages to the officials and residents of the Village, so as to facilitate administration, daily operation and avoid practical and legal entanglements; therefore this Ordinance shall be in force and effect immediately upon its passage and approval by the Mayor.
