

## ORDINANCE 14-13

### AN ORDINANCE ESTABLISHING THE COMPENSATION AND PAY SCHEDULES FOR CERTAIN POSITIONS WITHIN THE VILLAGE OF THORNVILLE AND REPEALING ALL PRIOR SALARY ORDINANCES

WHEREAS, earlier this year, with Ordinance 14-06, Council for the Village of Thornville established a compensation and pay schedule for certain positions within the Village of Thornville; and

WHEREAS, the Personnel Committee recently reviewed certain positions and the pay schedules for these positions. Following this review, the Personnel Committee recommended adjusting certain pay schedules. The yearly salary for councilmembers is not being changed; and

WHEREAS, Council for the Village of Thornville now wants to adopt the changes recommended by the Personnel Committee; and

WHEREAS, rather than amend only certain Sections, and thereby create a piecemeal compensation and pay schedule, Council for the Village of Thornville now wants to take advantage of its need to adjust the pay for certain workers and adopt a new comprehensive pay ordinance.

**NOW THEREFORE, BE IT ORDAINED** by the Council of the Village of Thornville, County of Perry, State of Ohio:

SECTION 1: The compensation and pay schedule for certain position within the Village of Thornville, Ohio, are here amended as follows:

SECTION 2: The yearly salary of the Village Administrator shall be Thirty Nine Thousand and One Hundred, and Forty Dollars and No Cents (\$39, 140.00) paid in equal bi-weekly installments.

SECTION 3: The hourly pay for the Administrative Assistant shall be Fifteen Dollars and Fifty-Seven Cents (\$15.57) per hour in bi- weekly.

SECTION 4: The yearly salary of Fiscal Officer shall be Twenty Thousand and Six Hundred and Sixty One Dollars and Three Cents (\$20, 661.03) paid in equal monthly installments.

SECTION 5: The hourly pay for part- time Clerk of Court shall be Thirteen Dollars and Fourteen Cents (\$13.14) per hour, paid monthly.

SECTION 6: The yearly salary pay for the part- time Mayor's Court Clerk shall be Two Thousand Four Hundred and Seventy Two Dollars and No Cents (\$2,472.00), paid in equal monthly installments. The total hours worked shall not exceed 20 hours per month.

SECTION 7: The hourly pay for the Full- time Licensed Water/Sewer Superintendent shall be Twenty Seven Dollars and Nineteen Cents (\$27.19) per hour, paid bi- weekly.

SECTION 8: The hourly pay for the Clerical/Administrator worker for the Village shall be Eight Dollars and Ten Cents (\$8.10) per hour, paid bi -weekly.

SECTION 9: The hourly pay for the full-time Water/Sewer Operator shall be Twenty -Two Dollars and Twenty Nine Cents (\$22.29) per hour, paid bi-weekly.

SECTION 10: The hourly pay for a full- time Water/Sewer Department Utility Laborer shall be Twelve Dollars (\$12.00) per hour, paid bi-weekly.

SECTION 11: The hourly pay for a part- time Water/Sewer Department Utility Laborer shall be Eleven Dollars and Nine Cents (\$11.09) per hour, paid bi-weekly.

- SECTION 12: The hourly pay for Water/Sewer Department Meter Reader shall be Eleven Dollars and Forty Two Cents (\$11.42) per hour, paid bi-weekly.
- SECTION 13: The hourly pay for a full-time General Maintenance Laborer shall be Fifteen Dollars and Fifty Five Cents (\$15.55) per hour, paid bi-weekly.
- SECTION 14: The yearly salary for the Zoning Inspector shall be Two Thousand Four Hundred Dollars (\$2,400.00), paid in equal monthly installments. Plus thirty percent (30%) of each permit fee collected by the Village, paid monthly.
- SECTION 15: The hourly pay for the part-time Zoning Secretary shall be Ten Dollars and Four Cents (\$10.04) per hour, paid monthly.
- SECTION 16: The hourly pay for the Pool Manager shall be Ten Dollars and No Cents (\$10.00) per hour, paid bi-weekly.
- SECTION 17: The hourly pay for the Assistant Manager shall be Eight Dollars and Thirty Five Cents (\$8.35) per hour, paid bi-weekly.
- SECTION 18: The hourly pay for a Lifeguard shall be Eight Dollars and Twenty Cents (\$8.20) per hour, paid bi-weekly.
- SECTION 19: The hourly pay for the Concession Stand Worker shall be Eight Dollars and Ten Cents (\$8.10) per hour, paid bi-weekly.
- SECTION 20: The yearly salary of a full-time Chief of Police shall be Thirty Six Thousand Nine Hundred and Seventy Two Dollars and Thirty Seven Cents (\$36,972.37) paid equal bi-weekly installments.
- SECTION 21: The yearly salary of a part-time Chief of Police who works only part-time, the yearly salary shall be Ten Thousand, Two Hundred Seventy Two Dollars and Seventy Seven Cents (\$10,272.77), paid in equal bi-weekly installments.
- SECTION 22: The hourly pay for a full-time Police Officer shall be Ten Dollars and Fifty- One Cents (\$10.51) per hour, paid monthly.
- SECTION 23: The hourly pay for a part-time Police Officer shall be Nine Dollars and Sixteen Cents (\$9.16) per hour, paid monthly.
- SECTION 24: The hourly rate for an Auxiliary Police Officer shall be no dollars and no cents (\$0.00) per hour. After one year of service and successful completion of the required hours of service with that year, the Auxiliary Police Officer shall receive a yearly stipend of Two Hundred Dollars (\$200.00) paid yearly on the anniversary date of such completion.
- SECTION 25: The yearly salary of the Mayor shall be Three Thousand Dollars (\$3,000.00), paid in equal quarterly installments.
- SECTION 26: The yearly of the President of Village Council shall be One Thousand and Two Hundred and Fifty Dollars (\$1, 250.00), paid in equal quarterly installments.
- SECTION 27: The yearly salary of a Council member shall be One Thousand Dollars (\$1,000.00), paid in equal quarterly installments.
- SECTION 28: It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that any and all deliberations of the Council and any of its committees that results in such formal actions were in meetings open to the public, in compliance with all legal requirements of the laws of State of Ohio.


SECTION 29: All prior legislation setting forth the hourly pay rate or yearly salary of any Village employees, worker, or laborer is hereby repealed in it's entirety.

SECTION 30: This Ordinance shall take effect and be in force on January 1, 2015.
