## **FORM OF AGREEMENT**

THIS AGREEMENT made this day of 2020, by and between the VILLAGE OF THORNVILLE, OHIO hereinafter called the "Village", and WASTE AWAY SYSTEMS, 995 Keller Drive, Heath, Oh 43056, or their successors, executors, administrators and assigns, hereinafter called "Waste Away Systems".

WITNESSETH: That for and in consideration of payments hereinafter mentioned to be made by Village and Waste Away Systems agrees as follows:

ARTICLE 1, SCOPE OF WORK: Waste Away Systems shall furnish all necessary personnel, equipment and special equipment, tools considered necessary and proper, an area of ground suitable for the disposal of garbage, rubbish, recyclables, bulk items and yard waste, to perform the services required by the aforementioned specifications in these contract documents and entitled "Contract for Refuse Hauling Services: for the VILLAGE OF THORNVILLE, OHIO.

ARTICLE 2, WORK TO BE PERFORMED: Work to be performed under this contract shall begin on January 1, 2021 and consist of collection and disposal of residential garbage, rubbish, bulk items, recyclables and yard waste with the frequencies and schedules specified elsewhere in these documents, and according to the price and terms described in Waste Away Systems BID submitted August 24, 2020 and specified elsewhere in these documents.

**ARTICLE 3, CONTRACT SUM:** Waste Away Systems is responsible for billing and collection from Village residents and shall not look to the Village of Thornville for payment.

**ARTICLE 4, TERM:** The original term of this Agreement shall commence January 1, 2021 and expire on December 31, 2023. At the conclusion of the term of this Agreement, the Agreement may be automatically renewed for additional three-year term upon mutual agreement of price by both parties.

**ARTICLE 5, PENALTIES:** Where work is incomplete, reductions may be made as covered in the attached documents.

ARTICLE 6, CONTRACT DOCUMENTS: Shall consist of the following:

- 1. Legal Notice
- 2. Bid Specifications and Forms
- 3. Bid Proposal
- 4. Form of Agreement
- 5. Contract Bond
