

ORDINANCE #20-19

ADOPTED ON: October 26, 2020

AN ORDINANCE AUTHORIZING AND DIRECTING THE VILLAGE ADMINISTRATOR AND FISCAL OFFICER TO EXECUTE A CONTRACT WITH ADR & ASSOCIATES, LTD., TO COMPLETE ENGINEERING WORK FOR THE WELL FIELD IMPROVEMENT PROJECT AND DECLARING AN EMERGENCY

WHEREAS, the Village of Thornville's Water Treatment Plant has two separate treatment trains. However, the Village has only one chlorination pump, which must be moved from one well to the other, as the operator alternates between the wells. This is not the safest and most efficient manner to run the Water Treatment Plant; and

WHEREAS, the Well Field Improvement Project will include constructing a building, piping both wells to the new building and using one set of chlorination pumps to service the reconfigured system. This will eliminate the need to switch chlorination equipment; and

WHEREAS, ADR & Associates Ltd. submitted a proposal to oversee the initial engineering and administrative processes associated with the Well Field Improvement Project. Specifically, ADR & Associates Ltd.'s scope of work shall include a survey, civil engineering and electrical engineering for the cost of \$16,500.00; and

WHEREAS, Council for the Village of Thornville would like to enter into a contract with ADR & Associates Ltd. in order to complete this engineering work relative to the Well Field Improvement Project.

NOW, **THEREFORE, BE IT ORDAINED** by the Council of the Village of Thornville, County of Perry, State of Ohio:

SECTION 1: The Village Administrator and Fiscal Officer are hereby authorized and directed to execute a contract with ADR & Associates, Ltd., to complete engineering work for the Well Field Improvement Project.

SECTION 2: The money to cover the cost of this work (\$16,500.00) already has been appropriated from the Water Fund.

SECTION 3: All prior legislation, or any parts thereof, which is/are inconsistent with this Ordinance is/are hereby repealed as to the inconsistent part thereof.

SECTION 4: It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that any and all deliberations of this Council, and that any and all deliberations of this Council and any of its committees that resulted in such formal actions were in meeting open to the public, in compliance with all legal requirements of the laws of the State of Ohio.


SECTION 5: Council declares this to be an emergency measure immediately necessary for the preservation of the public peace, health, and safety of this municipality and the further reason that Council needs to execute this contract as soon as possible so that this work can begin post haste. Wherefore, provided this Ordinance receives the required affirmative votes of Council, this Ordinance shall take effect and be in force immediately upon passage by Council.
