ORDINANCE #21-06

ADOPTED ON: April 26 2021

AN ORDINANCE AMENDING SECTION 21 OF ORDINANCE 21-01, THEREBY CHANGING THE HOURLY PAY FOR THE PART-TIME CONCESSION STAND WORKER AND DECLARING AN EMERGENCY

WHEREFORE, with Ordinance 20-11, adopted on September 28, 2020, Council for the Village of Thornville gave certain employees an additional one percent pay increase. In order to avoid piecemeal legislation, Ordinance 20-11 simply adopted a new comprehensive pay ordinance for 2020 that incorporated these raises; and

WHEREAS, with Ordinance 20-13, Council for the Village of Thornville gave certain employees a three percent (3%) pay increase for 2021, effective January 7, 2021; and

WHEREAS, with Ordinance 21-01, Council re-issued the 2021 Compensation and Pay Schedule to reflect the correct hourly pay for the part-time Zoning Secretary, set forth in Section 17; and

WHEREAS, the Village of Thornville needs to increase the hourly pay of the Part-Time Pool Concession Stand Worker by ten cents per hour to comply with the new hourly minimum wage rate for nontipped employees; and

WHEREAS, Council for the Village of Thornville now wants to amend Ordinance 21-01, Section 21 to reflect an hourly rate of Eight Dollars and Eighty Cents (\$8.80). No other pay rates are affected by this amendment.

NOW, **THEREFORE, BE IT ORDAINED** by the Council of the Village of Thornville, County of Perry, State of Ohio:

SECTION 1: Section 21 of Ordinance 21-01, adopted on January 25, 2021 is hereby amended to read as follows:

The hourly pay for the Part-time Concession Stand Worker shall be Eight Dollars and Eighty Cents (\$8.80) per hour, paid bi-weekly.

SECTION 2: All prior legislation, or any parts thereof, which is/are inconsistent with this Ordinance is/are hereby repealed as to the inconsistent part thereof.

SECTION 3: It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that any and all deliberations of this Council, and that any and all deliberations of this Council and any of its committees that resulted in such formal actions were in meeting open to the public, in compliance with all legal requirements of the laws of the State of Ohio.

SECTION 4: Council declares this to be an emergency measure immediately necessary for the preservation of the public peace, health, and safety of this municipality and the further reason that Council needs this amendment to become effective immediately upon passage so that it can pay the part-time Concession Stand Worker the new minimum wage that took effect on January 1, 2021. Wherefore, provided this Ordinance receives the required affirmative votes of Council, this Ordinance shall take effect and be in force immediately upon passage by Council.
