

ORDINANCE # 22-04

ADOPTED April 25 2022

AN ORDINANCE AMENDING THE RULES OF THE VILLAGE OF THORNVILLE COUNCIL, SECTION 8 (ORDER OF BUSINESS)

WHEREAS, R.C. 731.45 and Council Rule 2.03 allow Council for the Village of Thornville to determine, and subsequently amend, its own rules; and

WHEREAS, Council for the Village of Thornville last revised its rules on October 27, 2021 with Ordinance 21-15; and

WHEREAS, the Personnel Committee recently review Council's Rules and recommends Section 8 (Order of Business be amended by

- Making *Presentation and Payment of Bills* a subsection under Administrator's Report
- Adding *Monthly Reports* as a subsection under Fiscal Officer's Report
- Updating Item 16 to read *Comments and Announcements*
- Removing Items 18, 19 and 20; and

WHEREAS, Council for the Village of Thornville now wants to accept the Personnel Committee's recommendations and amend Section 8.

NOW, **THEREFORE, BE IT RESOLVED** by the Council for the Village of Thornville, Perry County, State of Ohio:

SECTION 1: Council for the Village of Thornville hereby amends Section 2 of the Thornville Rules of Council to read as follows:

8. ORDER OF BUSINESS

The Mayor shall take the chair at the hour appointed for the Council meeting, call the meeting to order, and direct the Clerk to call roll. If a quorum is present, the meeting shall continue.

The order of council business shall be as follows:

1. Call to Order
2. Pledge of Allegiance
3. Roll Call by Clerk of Council
4. Approval of Agenda
5. Review and Approval of Minutes
6. Public Hearings
7. Police Report
8. Mayor's Report
9. Administrator's Report
 - Presentation and Payment of Bills
10. Fiscal Officer's Report
 - Monthly Reports
11. Committee Reports
12. Zoning and Planning Commission Report
13. Unfinished Business
14. New Business
15. Executive Session (if necessary)
16. Comments & Announcements
17. Adjournment

SECTION 2: All other sections and subsections of the Rules of Village of Thornville Council shall remain unchanged, in effect, and enforceable.

SECTION 3: All prior legislation, or any parts thereof, which is/are inconsistent with this Ordinance is/are hereby repealed as to the inconsistent part thereof.

SECTION 4: It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that any and all deliberations of this Council and any of its committees that resulted in such formal actions were in meeting in open to the public, in compliance with all legal requirements of the laws of the State of Ohio.

SECTION 5: This Ordinance shall take effect at the earliest time allowed by law.
