AN ORDINANCE AMENDING AND REVISING THE 2024 APPROPRIATIONS OF THE VILLAGE OF THORNVILLE AND DECLARING AN EMERGENCY

WHEREAS, the Village of Thornville, Ohio, is authorized to adopt the Municipal Budget for the fiscal year beginning January 1, 2024, and ending December 31, 2024; and

- SECTION 5: This Ordinance is declared to be an emergency measure necessary for the health, safety and welfare of the residents of Thornville and the further reason that Council

needs to provide the necessary funds to meet requirements and obligations. Wherefore, provided this Ordinance receives the required affirmative votes of Council, this Ordinance shall take effect and be in force immediately upon passage by Council.
