AN ORDINANCE AMENDING AND REVISING SPECIFIC LINE-ITEMS IN THE APPROPRAIOTNS OF EXPENDITURES FOR THE VILLAGE OF THORNVILLE FOR THE CALENDAR YEAR 2025 AND DECLARING AN EMERGENCY:
