

ORDINANCE: 12-06

AN ORDINANCE AUTHORIZING THE VILLAGE ADMINISTRATOR, OR HIS DESIGNEE, TO ADVERTISE FOR BIDS THE SANITARY SEWER REHABILITATION PROJECT, PHASE I AND DECLARING AN EMERGENCY

WHEREAS, with Resolution 10-07, Council for the Village of Thornville authorized the Village Administrator, Mayor, and Fiscal Officer to participate in the Ohio Public Works Commission State Capital Improvement Program in order to make capital improvements to the sanitary sewer system; and

WHEREAS, the Village of Thornville anticipates beginning Phase I of the sanitary sewer rehabilitation project soon, and must secure the contract(s) to complete work on the Project through a competitive bidding process; and

WHEREAS, pursuant to R.C. 731.141, Council for the Village of Thornville now wants to advertise for bids the capital improvements known as the Sanitary Sewer Rehabilitation Project, Phase I.

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Thornville, County of Perry, State of Ohio:


SECTION 1: Council for the Village of Thornville hereby authorizes and directs the Village Administrator, or his designee, to advertise for bid the Sanitary Sewer Rehabilitation Project, Phase I for not less than two nor more than four consecutive weeks in a newspaper of general circulation within the village or as provided in R.C. 7.16. The bids shall be opened and publicly read by the Village Administrator or his designee at the time, date, and place as specified in the advertisement to bidders or specifications.

SECTION 2: It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that any and all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements of the laws of the State of Ohio.

SECTION 3: All prior legislation, or any parts thereof, which is/are inconsistent with this Ordinance is/are hereby repealed as to the inconsistent parts thereof.


SECTION 4: Council declares this to be an emergency measure immediately necessary for the preservation of the public peace, health, and safety of this municipality and the further reason that the Village wants to advertise this work immediately so that prospective bidders can respond, the Village can award this contract, and the work can be complete as soon as possible. Wherefore, provided this Ordinance receives the required affirmative votes of Council, it shall take effect and be in full force immediately upon passage by Council.
