NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Thornville, County of Perry, State of Ohio:

- SECTION 1: approved by Council for the Village of Thornville, is hereby approved, adopted, and enacted. Any prior version of the Ohio Basic Code which may have been American Legal Publishing's Ohio Basic Code, 2021 Edition, as reviewed and hereby replaced in its entirely by the Ohio Basic Code, 2021 Edition. previously adopted by the Village of Thornville is hereby repealed as obsolete and
- SECTION 2: One copy of American Legal Publishing's Basic Code, 2021 Edition, certified as in the Code of Ordinance as required R.C. 731.23. Such summary is attached hereto correct by the Mayor and Clerk of Council, as required by R.C. 731.23, shall be kept in its initial form on file in the office of the Clerk. The Clerk of Council is hereby authorized and directed to publish a summary of all new matters contained "Exhibit A" and incorporated herein by reference.
- SECTION 3: All ordinances and resolutions or parts thereof which are in conflict or inconsistent with all provisions of the Ohio Basic Code, 2021 Edition, as adopted in Section 1 hereof, are hereby repealed as of the effective date of this Ordinance, except as
- (A) The enactment of the Ohio Basic Code, 2021 Edition, shall not be construed to affect a revision and codification. affect an indictment or prosecution thereof. For such purposes, any such legislative punishment for an act committed in violation of any such legislative provision, nor to such right or liability. Such enactment shall not be construed to relieve any person from effective date of such enactment, or an action or proceeding for the enforcement of right or liability accrued or incurred under any legislative provision prior to the provision shall continue in full force notwithstanding its repeal for the purpose of
- (B) The repeal provided above shall not affect:
- The grant or creation of a franchise, license, right, easement or privilege
- The purchase, sale, lease or transfer or property.
- The appropriation or expenditure of money or promise or guarantee of payment

SECTION 4: Whenever reference is made in any documents, publications, or signs of the Village of Thornville, including but not limited to traffic tickets and traffic-control signs, to a section as it existed in a former edition of the Ohio Basic Code, the reference shall extend and apply to the section referred to as subsequently amended, revised, recodified, or renumbered.

SECTION 5: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of meetings open to the public in compliance with all legal requirements of the State bodies of the Village of Thornville which resulted in such formal actions were in Council and that all deliberations of the Council and any of the decision-making

SECTION 6: This Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, welfare and safety and for the further reason that there exists an imperative necessity for the earliest publication and avoid practical and legal entanglements. Wherefore, provided this Ordinance receives the required affirmative votes of Council, it shall take effect and be in full distribution or current Code, so as to facilitate administration, daily operation and force immediately upon passage.
