A RESOLUTION AUTHORIZING THE VILLAGE ADMINISTRATOR TO ACCEPT THE BID OF KMA SERVICES EXCAVATING & TRUCKING, LLC AND AUTHORIZING THE VILLAGE ADMINISTRATOR AND FISCAL OFFICER TO EXECUTE AN AGREEMENT WITH KMA SERVICES EXCAVATING & TRUCKING, LLC TO DEMOLISH THE PROPERTY OF 6 SOUTH MAIN STREET, THORNVILLE, OHIO AND DECLARING AN EMERGENCY

WHEREAS, with Ordinance 12-07, Council for the Village of Thornville authorized the Village Administrator, or his designee, to advertise for bids to demolish the property of 6 South Main St, Thornville, Ohio; and

WHEREAS, the Village of Thornville received four (4) bid responses prior to the deadline, and

WHEREAS, the Village Administrator reviewed the bid responses and recommend the project be awarded to KMA Services Excavating & Trucking, LLC; and

WHEREAS, Council of the Village of Thornville does hereby recognize the need to enter into an agreement with the lowest and best bidder and believes KMA Services Excavating & Trucking, LLC's bid meets this requirement.

NOW, **THEREFORE, BE IT RESOLVED** by the Council of the Village of Thornville, County of Perry, State of Ohio:

SECTION 1: Council for the Village of Thornville hereby authorizes and directs the Village Administrator to accept the bid of KMA Services Excavating & Trucking, LLC to demolish the property of 6 South Main St, Thornville, Ohio.


SECTION 2: The Village Administrator and Fiscal Officer are hereby authorized and directed to execute an agreement with KMA Services Excavating & Trucking, LLC to demolish the property of 6 South Main St, Thornville, Ohio.

SECTION 3: All prior legislation, or any parts thereof, which is/are inconsistent with this Resolution is/are hereby repealed as to the inconsistent parts thereof.



Wherefore, provided this Resolution receives the required affirmative votes of Council, this Resolution shall take effect and be in force immediately upon passage by Council.
