## RESOLUTION No. 13-006

A RESOLUTION ACCPETING THE AMOUNTS AND RATES AS DETERMINED BY THE BUDGET COMMISSION, AUTHORIZING THE NECESSSARY TAX LEVIES, CERTIFYING THEM TO THE COUNTY AUDITOR, AND DECLARING AN EMERGENCY

WHEREAS, on September 23, 2013, with Resolution 13-005, Council for the Village of Thornville timely adopted legislation accepting the amounts and rates that have been determined by the Budget Commission; and

WHEREAS, the Village Administrator just realized there was a clerical error in Resolution 13-005, whereby the fiscal year was identified as beginning January 1, 2013 instead of January 1, 2014; and

WHEREAS, the Perry County Auditor would like Council for the Village of Thornville to adopt a new piece of legislation that identifies the correct fiscal year; and

WHEREAS, Council for the Village of Thornville now wants to clarify the fiscal year and correct this clerical error.

NOW, **THEFORE**, **BE IT RESOLVED** by the Council of the Village of Thornville, County of Perry. State of Ohio:

- SECTION 1: Council for the Village of Thornville, in accordance with the provisions of law, has previously adopted a Tax Budget for the next succeeding fiscal year commencing January 1, 2014.
- SECTION 2: The Budget Commission of Perry County, Ohio has certified its action thereon to the Council for the Village of Thornville together with an estimate by the County Auditor of the rate of each tax necessary to be levied by the Council, and what part thereof is without, and what part within, the ten mill tax limitation.
- SECTION 3: The amounts and rates, as determined by the Budget Commission in its certification, be and the same are hereby accepted.
- SECTION 4: There be, and is hereby, levied on the tax duplicate of the Village of Thornville that rate of each tax necessary to be levied within and without the ten million limitation as set forth on Schedule A and Schedule B attached hereto and incorporated herein by reference.
- SECTION 5: The Clerk of this Council hereby directed to immediately certify a copy of this Resolution to the Perry County Auditor.
- SECTION 6: All prior legislation, or any parts thereof, which is/are inconsistent with this Resolution is/are repealed as to the inconsistent parts thereof.

- SECTION 7: It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this legislation were adopted in an open meeting of this Council, and that any and all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements of the laws of the State of Ohio.
- SECTION 8: Council declares this to be an emergency measure immediately necessary for the preservation of the public peace, health, and safety of this municipality and the further reason that the Village needs to certify this Resolution to the County Auditor immediately. Wherefore, provided this Resolution receives the required affirmative votes of Council, it shall take effect and be in full force immediately upon passage by Council.
