A RESOLUTION ACKNOWLEDGING AND ACCEPTING RESIDENTS BONNIE AND GENE GOLDSBERRY'S DONATION TO FUND THE PARKING LOT PAVING PROJECT AT THE HARRY L. HITE MEMORIAL SWIMMING POOL AND DECLARING AN EMERGENCY

WHEREAS, the Village of Thornville's Harry L. Hite Memorial Swimming Pool recently underwent much-needed paving of its parking lot; and

WHEREAS, Council for the Village of Thornville learned that residents Bonnie and Gene Goldsberry voluntarily and generously agreed to fund this important public improvement project, paying the contractor directly for the complete cost of the paving. This project cost \$12, 688.00; and

WHEREAS, this generous donation helps provide safer access to the Village's swimming pool and promotes the general welfare, health, safety, and overall enjoyment of Village residents;

WHEREAS, Council for the Village of Thornville now wants to formally acknowledge and thank the Goldsberry's for their generous and worthwhile gift.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Thornville, County of Perry, State of Ohio:

- SECTION 1: Council for the Village of Thornville hereby acknowledges and accepts Bonnie and Gene Goldsberry's, who reside at 68 N. Main Street, Thornville, Ohio, generous donation of \$12,688.00, which was paid directly to the contractor, for the paving of the Village of Thornville's Harry L. Hite Memorial Swimming Pool. Council for the Village of Thornville thanks Bonnie and Gene Goldsberry for their continued philanthropic support of the Village.
- SECTION 2: All prior legislation, or parts thereof, which is/are inconsistent with this Resolution is/are hereby repealed as to the inconsistent parts thereof.
- SECTION 3: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of Council and any decision-making bodies of the Village of Thornville, which resulted in such formal actions, were in meetings open to the public in compliance with all legal requirements of the State of Ohio.
- SECTION 4: Council declares this to be an emergency measure immediately necessary for the preservation of the public peace, health, and safety of the Village and the further reason that the Village needs to timely thank the Goldsberry's. Wherefore, provided this Resolution receives the required affirmative votes of Council, this Resolution shall take effect and be in force immediately upon passage by Council.
