A RESOLUTION DECLARING THE NECESSITY TO LEVY A TAX OUTSIDE THE TENMILL LIMITATION AND REQUESTING THE PERRY COUNTY AUDITOR CERTIFY TO THE VILLAGE OF THORNVILLE THE TOTAL CURRENT VALUATION OF THE VILLAGE OF THORNVILLE AND THE DOLLAR AMOUNT OF REVENUE THAT WILL BE GENERATED BY A RENEWAL TAX LEVIED IN THE AMOUNT OF 0.75 MILL FOR PARKS AND RECREATIONAL PURPOSES

WHEREAS, Council of the Village of Thornville, which is the taxing authority of the Village of Thornville, finds the amount of taxes that may be raised within the ten-mill limitation will be insufficient to provide for the necessary requirements of the Village, and that it is necessary to levy a renewal tax of 0.75 mill for five years, in excess of that limitation, for parks and recreational purposes, pursuant to R.C. 5705.19(H); and

WHEREAS, Council for the Village of Thornville now needs to request the Perry County Auditor certify certain information to the Village of Thornville in connection with the proposed renewal tax of 0.75 mills, for five (5) years for parks and recreational purposes.

NOW, **THEREFORE**, **BE IT RESOLVED** by the Council of the Village of Thornville, County of Perry, State of Ohio:

- SECTION 1: Council for the Village of Thornville hereby declares the amount of taxes that may be raised within the ten-mill limitation will be insufficient to provide for the necessary requirements of the Village, and therefore, it is necessary to levy a tax in excess of that limitation for the purposes set forth in R.C. 5705.19(H).
- SECTION 2: The purpose of the renewal three-fourths (0.75) mill tax will be for parks and recreational purposes.
- SECTION 3: The 0.75 mill tax is the renewal of an existing tax with an increase (increased from 0.50 mill).
- SECTION 4: The tax is authorized by R.C. 5705.19(H).
- SECTION 5: The term of years of the tax: five (5) years
- SECTION 6: The tax will be levied upon the entire territory of the Village of Thornville.
- SECTION 7: The question of the tax shall appear on the November 5, 2024 ballot.
- SECTION 8: The ballot measure of the renewal 0.75 mill tax shall be submitted to the entire territory of the Village of Thornville.
- SECTION 9: The renewal tax will first be levied in tax year 2024 (starting on January 1, 2024) and will be first collected in the 2025 calendar year.
- SECTION 10: The Village of Thornville has territory only in Perry County.
- SECTION 11: Pursuant to R.C. 5705.03(B), the Perry County Auditor is hereby requested to certify to the Village of Thornville the total current tax valuation of the Village of Thornville and the dollar amount of revenue that will be generated by a renewal tax levied in the amount of three-fourths (0.75) mill.
- SECTION 12: The Clerk is hereby directed to certify this Resolution to the Perry County Auditor.
- SECTION 13: The forgoing certification shall be issued by the Perry County Auditor to the Village of Thornville in accordance with R.C. 5705.03(B)(2)

- SECTION 14: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision-making bodies of the Village of Thornville which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.
- SECTION 15: All prior legislation, or any parts thereof, which is/are inconsistent with this Resolution is/are hereby repealed as to the inconsistent parts thereof.
- SECTION 16: Pursuant to R.C. 5709.19, this Resolution shall go into effect immediately upon its passage, and no publication of this Resolution is necessary other than that provided for in the notice of election.
