

RESOLUTION NO. 25-27

ADOPTED ON 12-15-25

A RESOLUTION TO HIRE BRYAN YANTIS AS THE VILLAGE OF THORNVILLE WATER & SEWER OPERATOR AND DECLARING AN EMERGENCY

WHEREAS, there currently is a vacancy in the position of full-time Licensed Water Operator I / Licensed Sewer Operator 1 for the Village of Thornville; and

WHEREAS, the Village Administrator recommends hiring Bryan Yantis to fill this vacancy because of his extensive background in water and sewer infrastructure; and

WHEREAS, for thirteen years, Bryan Yantis was employed at the Licking County Water & Wastewater Plant; and

WHEREAS, Council for the Village of Thornville understands the importance of this position and believes Bryan Yantis has the necessary experience to serve as the next Village Water & Sewer Operator.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Thornville, County of Perry, State of Ohio:

SECTION 1: Council for the Village of Thornville hereby hires Bryan Yantis as Licensed Water Operator I / Licensed Sewer Operator 1 for the Village of Thornville.

SECTION 2: Bryan Yantis shall be:

- a. Paid according to the current, and as later amended, Village of Thornville Compensation and Pay Schedule.
- b. Eligible for a pay increase if he receives a Class I Water Operator Certification.
- d. Credited with 0 hour of Vacation Leave, as allowed under Section IX (Vacation Leave) of the Village of Thornville Personnel Manual. These hours are being recognized from his previous employment with Licking County Water & Wastewater Plant.

SECTION 3: All prior legislation, or any parts thereof, which is/are inconsistent with this Resolution is/are hereby repealed as to the inconsistent parts thereof.

SECTION 4: It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that any and all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements of the laws of the State of Ohio.

SECTION 5: This Resolution is hereby declared an emergency measure necessary for the health, safety, and welfare of the residents of the Village and for the further reason that the Village must fill this position as soon as possible. Wherefore, provided this Resolution receives the required affirmative votes of Council, it shall take effect and be in full force immediately upon passage by Council.


