

RESOLUTION NO 20-07
ADOPTED November 23 2020

A RESOLUTION TO ACCEPT THE BID OF, AND EXECUTE A CONTRACT WITH, WASTE AWAY SYSTEMS FOR THE WEEKLY CURBSIDE COLLECTION AND DISPOSAL OF RESIDENTIAL TRASH, REFUSE, AND YARD WASTE WITHIN THE VILLAGE OF THORNVILLE AND DECLARING AN EMERGENCY

WHEREAS, the current contract for the weekly collection, transportation and disposal of all garbage, trash, refuse, and yard waste from residential premises located within the incorporated area of the Village of Thornville will expire on December 31, 2020; and

WHEREAS, the Village of Thornville advertised for bids for a new three-year trash contract. Notice was given, pursuant to R.C. 7.16, in the Newark Advocate on July 29, 2020 and August 5, 2020; and

WHEREAS, a Pre-Bid Teleconference for all bidders was held via Zoom on Friday August 7, 2020 at 12 p.m.; and

WHEREAS, the Village received four (4) bids, which were opened on August 24, 2020 at 12:00 p.m. via a Zoom teleconference; and

WHEREAS, having reviewed these bids, the Council for the Village of Thornville believes WASTE AWAY SYSTEMS submitted the lowest and best bid.

NOW, **THEREFORE, BE IT RESOLVED** by the Council of the Village of Thornville, County of Perry, State of Ohio that:

SECTION 1: The Village Administrator is hereby authorized and directed, on the behalf of the Village of Thornville, to accept the bid of, and execute a contract, in substantially the same form and content as the Contract attached hereto as Exhibit A and incorporated herein by reference, with Waste Away Systems for the weekly collection, transportation and disposal of all garbage, trash, refuse, and yard waste from residential premises located within the incorporated area of the Village of Thornville.

SECTION 2: All prior legislation, or any parts thereof, which is/are inconsistent with this Resolution is/are hereby repealed as to the inconsistent parts thereof.

SECTION 3: It is hereby found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that any and all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements of the laws of the State of Ohio.


