

RESOLUTION NO: 23-13

ADOPTED: August 29 2023

A RESOLUTION ADOPTING THE PERRY COUNTY 2023 MULTI-HAZARD MITIGATION PLAN (DATED JULY 7, 2023) AND DECLARING AN EMERGENCY

WHEREAS, Council for the Village of Thornville recognizes the threat that natural hazards pose to people and property within the Village; and

WHEREAS, the Perry County Emergency Management Agency prepared a multi-hazard mitigation plan, known as the Perry County 2023 Multi-Hazard Mitigation Plan (dated July 7, 2023) in accordance with federal laws, including the Robert T. Stafford Disaster Relief and Emergency Assistance Act, as amended; the National Flood Insurance Act of 1968, as amended; and the National Dam Safety Program Act, as amended; and

WHEREAS, the Perry County 2023 Multi-Hazard Mitigation Plan identifies mitigation goals and actions to reduce or eliminate long-term risk to people and property in the Village of Thornville from the impacts of future hazards and disasters; and

WHEREAS, by adopting the Perry County 2023 Multi-Hazard Mitigation Plan, Council for the Village of Thornville demonstrates its commitment to hazard mitigation.

NOW, **THEREFORE, BE IT RESOLVED** by the Council of the Village of Thornville, County of Perry, State of Ohio:

SECTION 1: The Village of Thornville hereby adopts the Perry County 2023 Multi-Hazard Mitigation Plan (dated July 7, 2023).

SECTION 2: While content related to the Village of Thornville may require revisions to meet the plan-approval requirements, changes occurring after adoption of this Resolution will not require Council for the Village of Thornville to re-adopt any further iterations of the plan. However, subsequent plan updates following the approval period for this plan will require separate adoption resolutions.

SECTION 3: All prior legislation, or any part thereof, which is/are inconsistent with this Resolution is/are hereby repealed as to the inconsistent parts thereof.

SECTION 4: It is hereby and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in opening meeting of this Council and that any and all deliberating if this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements of the laws of the State of Ohio.

SECTION 5: This Resolution shall take effect at the earliest time allowed by Ohio law.
