the rate of each tax necessary to be levied by this Council, and what part thereof is without,  
and what part within the ten mill tax limitation; therefore be it

**RESOLVED**, By the Council of the Village of **THORNVILLE**,  
**PERRY** County, Ohio, that the amounts and rates, as determined by the Budget  
Commission in its certification, be and the same are hereby accepted; and be it further

**RESOLVED**, That there be and is hereby levied on the tax duplicate of said Village the  
rate of each tax necessary to be levied within and without the ten mill limitation as follows:
